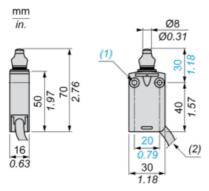

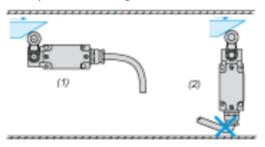

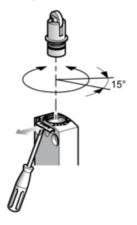
## Sweep of Connecting Cable

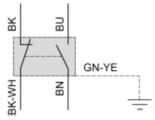

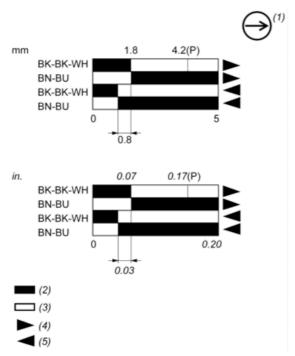
