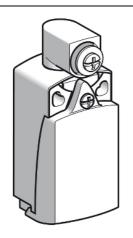

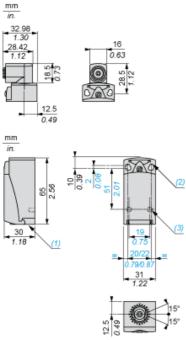

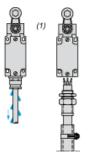

Position of Cable Gland

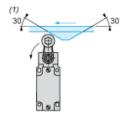


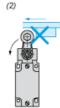

Mounting with Rotary Heads and Levers

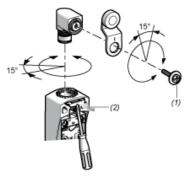

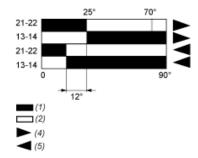
