

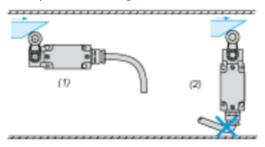


#### Sweep of Connecting Cable








